Safer Lives for Women, Men and Children

The NSW Government is implementing a range of initiatives to reform the domestic and family violence service system. These include the *NSW Domestic and Family Violence Blueprint for Reform 2016-2021*, and the NSW Government Premier's Priority to reduce domestic violence reoffending by 2021.

We are continuing to build a domestic and family violence service system that prevents violence, intervenes early with vulnerable communities, supports victims, holds perpetrators accountable, and delivers evidence-based quality services to make victims safer and support their recovery.

Continued to support women through the **WOMEN'S DOMESTIC VIOLENCE COURT ADVOCACY SERVICE**, with


Commenced redesign of the **DOMESTIC VIOLENCE DISCLOSURE SCHEME** based on an independent evaluation.



To support the actions outlined in the NSW Domestic and Family Violence Blueprint for Reform 2016-2021: Safer Lives for Women, Men and Children, the **2018-19 NSW Budget** delivers **\$390 million** over four years to specialist domestic and family violence initiatives, an increase from the \$350 million commitment in the 2016-17 NSW Budget. This investment is in addition to the hundreds of millions of dollars the government spends each year to combat domestic and family violence through mainstream services in **justice, police, health, child protection, social housing and homelessness services**.
